Regular Monthly Meeting
Minutes of December 9, 2025**

Supervisor Hebert called the meeting to order at 7:00 pm at the Ganges Township Hall, located at the corner of 119th Ave and 64th St. Board members present by roll call: Hutchins, Reimink, Hebert, Thompson. Absent: Phelps

Additions to Agenda: 11 C Short-Term Rental Moratorium addition. Reimink moved, Hutchins seconded, to approve the agenda dated 12/09/2025 with the addition. Motion carried.

Correspondence

Annual report received from the Planning Commission, and a letter from Varnum representing Saugatuck Weekends, appealing the Campground Moratorium.

Public Comments

Allegan County Judge Margaret Bakker informed the board and audience about the Allegan County Legal Assistance Center. Judge Bakker left literature and asked the township to help educate the community about this free service.

Hutchins moved, Reimink seconded, to approve the Regular Meeting Minutes of 11/11/2025. Motion carried.

Hebert moved, Reimink seconded, to approve the Special Meeting Minutes of 11/24/2025. Motion carried.

Hebert moved, Hutchins seconded, to approve the Closed Session Meeting Minutes of 11/24/2025. Motion Carried

Committee Reports

Fire Dept.- Angel Boyles-Jager reported that the final number of calls for 2025 will be less than in previous years. The Fire Department is requesting the purchase of materials for two new students to attend the Fire Academy starting in January at \$750 per student, and one student for the MFR class through the Fennville Fire Department, with a cost of \$800.

Hebert moved, Reimink seconded, to approve the classes. Motion carried.

Sexton- Hebert reported for Broe that it has been quiet and there were no burials this month.

Planning Commission - Hutchins reported that the Planning Commission will be wrapping up the campground corrections at next week's meeting, as this is the top priority. The committee has finished the definitions and is continuing to work on rules and regulations.

Unfinished Business

Hebert moved, and Reimink seconded, to approve the Township Work Order on Public Roads for paving projects, and crack, chip and fog projects. Motion carried.

New Business

Herbert moved, Reimink seconded, the appointment of Charles Mannion of 6611 Deer Trail to the Ganges Township Zoning Board of Appeals. Motion carried.

Reimink moved, Hebert seconded, the three-year prepaid Provident Accident and Health Policy, which covers all Township employees. Motion carried.

Herbert moved to, and Hutchins seconded, to approve the ordinance imposing a temporary moratorium on short-term rentals drafted by the township attorney, effective until June 30, 2026.
