Motion carried.

Hebert moved, and Hutchins seconded to approve the road commission to send the work order for 2025 Resurfacing Projects which include the following Crack, Chip & Fog; 60th St-115th Ave to 116th Ave (Split 50/50 with Clyde Twp), 120th Ave-68th St to 66th St, 64th St-116th Ave to 118th Ave, 71st St-114th Ave to 116th Ave, 114th Ave-71st St to Blue Star Hwy. Also, Paving-119th Ave, 66th St to 64th St. Motion carried.

Hebert moved, Reimink seconded, to appoint Katie Wolfe to the Recording Secretary position for the Planning Commission and the Zoning Board of Appeals. Motion carried.

Reimink moved, Hebert seconded, to approve the 2025 Poverty Exemption Guidelines. Motion carried.

Hebert moved, Phelps seconded, to accept the Insurance proposal from Decker Agency. Motion carried.

Hebert moved, Reimink seconded, to approve the Outdoor Event Application for 2025 from Virtue Cider. Motion carried.

Hebert moved, Reimink seconded, to approve the quote for blinds for the township hall to be purchased with a Federal Election Security Grant. Motion carried.
