Jason Jager, Fire Chief, reported that calls were up this month, total of 30. Truck 671 had plug installed by C-Comm. Flow test is scheduled for April 28. MFRs are up to date.

AJ Broe, Cemetery Sexton was absent.

Dick Hutchins, PC Representative, reported that the Planning Commission met on March 25 for the Public Hearing on the proposed Zoning Ordinance update. He summarized the big changes

Motion carried by roll call vote as follows: Hutchins-Y, Reimink-Y, Hebert-Y, Phelps-Y, Thompson-Y. (5/0)

Hebert offered up, seconded by Phelps, the resolution of support for 123NET's Application for the Broadband Equity Access & Deployment(BEAD) Grant Program toward the Allegan County Broadband Wired Infrastructure Expansion Project. Motion carried by roll call vote as follows: Hutchins-Y, Reimink-Y, Hebert-Y, Phelps-Y, Thomspon-Y. (5/0)

Hebert approved, seconded by Reimink to approve to send a letter of support for Frontier's application for a BEAD grant. Motion carried.
