### AN ORDINANCE TO AMEND THE GANGES TOWNSHIP ZONING ORDINANCE AND IMPOSE A TEMPORARY MORATORIUM ON RECREATIONAL VEHICLE PARKS AND CAMPGROUNDS

An Ordinance to protect the public health, safety, and welfare by establishing regulations relating to a moratorium on considering applications for recreational vehicle parks and campgrounds while the Township completes a study of the zoning regulations pertaining thereto and possible subsequent revisions to the current Zoning Ordinance; to provide for severability; to repeal all ordinances or parts of ordinances in conflict therewith; and to provide an effective date.

### THE TOWNSHIP OF GANGES ALLEGAN COUNTY, MICHIGAN

### SECTION I FINDINGS

In accordance with Public Act 246 of 1945, MCL 41.181 *et seq.*, as amended, Ganges Township has determined the following:

- 1. It has been a significant period of time since the Ganges Township Zoning Ordinance has been studied with regard to recreational vehicle parks and campgrounds as a special use.
- 2. The Township Board, Planning Commissioners, and members of the public have provided substantial comments and information raising public health, safety, and welfare concerns regarding use of property within the Township for a recreational vehicle park and campground.
- 3. The Township Board has public health, safety, and welfare concerns regarding the special use of a recreational vehicle park and campground and finds that it requires time to study the zoning regulations with regard to such use.
- 4. The Township finds that imposing a moratorium upon the consideration of any applications for special use for a recreational vehicle park and campground, on a limited temporary basis, is reasonable and necessary for, among other reasons, the following reasons:
  - A. Michigan courts have recognized that a moratorium is a common and legitimate planning tool to preserve the status quo while formulating a development strategy.
  - B. The contemplated moratorium would allow the study of the public health, safety,

- and welfare concerns regarding the special use of a recreational vehicle park and campground and allow for any needed Zoning Ordinance update and implementation process to occur.
- C. The contemplated moratorium would allow the study and possible implementation of revisions to the Zoning Ordinance to occur with citizen input and involvement, public debate, and full consideration of all issues and points of view.
- D. The contemplated moratorium would allow for consideration of changes in land use that have occurred since the provisions regarding recreational vehicles and campgrounds were last addressed.
- 5. A moratorium should be imposed upon the consideration of any applications for special use recreational vehicle parks and campgrounds until June 30, 2026 or until an amendment to the Zoning Ordinance is adopted, whichever occurs first.

### SECTION II MORATORIUM

A temporary moratorium is imposed on the acceptance and/or processing of applications for RV parks or campgrounds, public or private, as defined by the Township Zoning Ordinance.

# SECTION III AMENDMENT TO GANGES TOWNSHIP ZONING ORDINANCE SECTION 6.2 TABLE OF USES IN THE R/A RESIDENTIAL AGRICULTURAL DISTRICT

Section 6.2 of the Ganges Township Zoning Ordinance, titled "Table of Uses" regarding the R/A Residential/Agricultural District is hereby amended to remove from the Table of Uses: "Campground, public or private."

## SECTION IV AMENDMENT TO GANGES TOWNSHIP ZONING ORDINANCE SECTION 11.2 TABLE OF USES IN THE C COMMERCIAL DISTRICT

Section 11.2 of the Ganges Township Zoning Ordinance, titled "Table of Uses" regarding the C Commercial District is hereby amended to remove from the Table of Uses: "Campground or RV park."

### SECTION V AMENDMENT TO GANGES TOWNSHIP ZONING ORDINANCE SECTION 18.6 SPECIFIC SPECIAL LAND USE STANDARDS

Section 18.6 of the Ganges Township Zoning Ordinance, titled "Specific Special Land Use Standards" is hereby amended to strike Section 18.6(C) in its entirety, and in its place shall be written the following: "Campgrounds, public or private, are subject to a temporary moratorium. Special land use permit applications for campgrounds, public or private, shall not be considered until the moratorium expires."

#### SECTION VI TERM OF MORATORIUM

The moratorium imposed by this ordinance will remain in effect until June 30, 2026, or until amendments to the Zoning Ordinance become effective, whichever occurs first. Before this moratorium expires, the Township Board may by resolution extend the moratorium as appropriate to allow sufficient time to complete amendments to its ordinances. If an extension is adopted, the Township will publish notice of the same.

#### SECTION VII SEVERABILITY

The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word, section or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

### SECTION VIII REPEAL

All ordinance or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

### SECTION IX EFFECTIVE DATE

This ordinance shall take effect eight days following publication following adoption.
